## FREQUENTLY ASKED ELECTION QUESTIONS

### 1) Where is City Hall?

You can find us at 427 Rio Grande Place across from the Rio Grande Park.

The City Clerk's office is located on the 3<sup>rd</sup> floor.

### 2) Am I eligible to vote in the Municipal Election?

You may vote if you have resided at an address within the City of Aspen for 22 days preceding the election (March 10th), registered with the State of Colorado and at least 18 years old on election day.

You may register to vote through election day.

- On or after March 28th, through election day, visit the [Pitkin County Clerk](#) to register

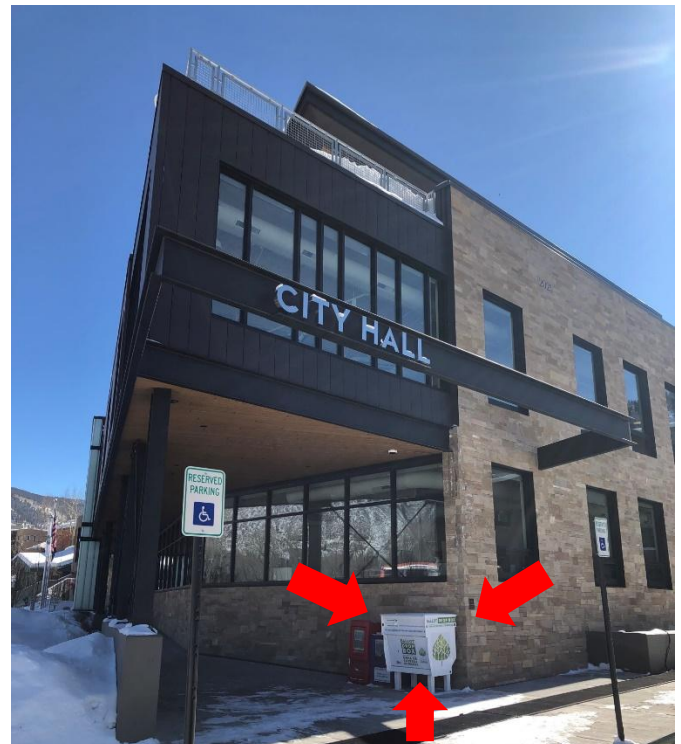
### 3) How can I return my mail ballot?

You have the following options to return your ballot.

- Drop it in the mail
- Drop it in the 24-hour secure Ballot Box located outside the front of City Hall at 427 Rio Grande Place as shown here →
- Drop it in the Ballot Box located at the City Clerk's Office on the third floor of City Hall M - F, 8am - 5pm March 13<sup>th</sup> - March 31<sup>st</sup> and on Election Day, April 1<sup>st</sup> from 7am – 7pm.

*If mailing your ballot, please allow enough time for the ballot to be received by the City Clerk by 7PM, April 1<sup>st</sup>, 2025! Postmarks do not count!*

*Please note this is a City Election, so you can **NOT** drop your ballot at the County Clerk's office on Main St!*





## FREQUENTLY ASKED ELECTION QUESTIONS

### 4) What do I do if I don't receive my ballot in the mail?

Ballots will be mailed on Wednesday, March 12<sup>th</sup> to active registered voters within the City of Aspen.

If you do not receive your ballot by March 24<sup>th</sup>, please contact the City Clerk's office at 970-429-2686 or [elections@aspen.gov](mailto:elections@aspen.gov).

***USPS will not forward ballots!***

### 5) Can I vote early in-person?

Yes! Early voting begins Monday, March 17<sup>th</sup>, in City Hall, 3<sup>rd</sup> Floor between 8am – 5 pm.

**Please bring an ID!**

### 6) What if I'm out of town during the election?

### 7) How is the winner of the Run-off Election determined?

Below is a description of how the winner of a Run-off Election for two Council vacancies is determined. This process is further described in the [City of Aspen Home Rule Charter, Article II](#).

#### **COUNCIL**

If a run-off election is required for two vacancies for City Council, then the four (4) persons with the highest number of votes for the office of member of Council in the municipal election shall appear on the ballot for members of Council. The two persons receiving the highest number of votes in the run-off election shall be elected for a four-year term. In this event, each voter shall be allowed to cast two votes for the office of member of Council.
